## 4. BUSINESS ARISING FROM THE MINUTES

#### 4.1 **Grey-headed Flying-fox Relocation Steering Committee**

Ilona Roberts reported that the minutes of the Steering Committee's final meeting, held on 27 October 2011 have not yet been circulated despite a request.

Motion: That the Royal Botanic Gardens & Domain Trust be advised that all communications regarding the Grey Headed Flying Fox relocation from the Royal Botanic Gardens be directed to the NWC via the Chair, which will undertake to advise those member groups affected by the action.

#### Moved: Audrey Koosmen Seconded: Helen Kennedy Motion carried

Actions: Chair to write to Mark Savio, Director, RBG&DT and copy to John Martin, Wildlife Management Officer (Project Officer)

Vice Chair to contact Storm Stanford seeking her agreement to collate any reports and photographs of flying fox casualties that might be related to the RBG relocation.

## 4.2 Website

The letter of appreciation to Steve Amesbury was sent. The circumstances of setting up the new account with VentralIP were explained (see Agenda Item 8.7)

## 4.3 Governance Issues: Declaration of Interest Register

Action: The Secretary will circulate a draft policy regarding declarations of interest with the intent to implement the annual register of declarations at the AGM in August 2012.

## 4.4 **Review of the NWC Constitution**

Philip Machin requested that members provide comment on the draft Constitutional changes which have previously been circulated by March 15<sup>th</sup> 2012.

There was agreement that provision would be made for postal voting.

Action: Comments on the review of the NWC Constitution to be emailed to Phil Machin by 15 March.

## 4.5 Shared Database Working Group

Rochelle reported that Ron Haering was advised at the Executive meeting in November of the decision to continue investigations as neither the Long Grass nor WIRES systems meet the needs identified. The question of data ownership was also raised with him.

The Working Group is to contact Patrick Connor principal, WIRES CarerHQ, for further discussion.

## 4.6 **Grants to Wildlife Carers**

James Fitzgerald referred to the draft proposal he had prepared and circulated to fund small projects that improve wildlife rehabilitation. He stressed the advantages of raising awareness about the huge effort wildlife rehabilitators invest each day in the care of each animal. James pointed out that this information is highly valued and has the potential to attract more funding.

Members discussed the mechanisms for individuals or groups applying for funding under this program.

Four funding options including James' generous offer to privately fund the project and NWC funds, provided by the RMS, were discussed and voted on.

- 1. 5 year trial, funded by James' Trust (four votes)
- 2. 1 year trial, funded by NWC (four votes)
- 3. 1 year trial, 50/50 cost share between NWC and James' trust (Nil)
- 4. 2 year trial, 50/50 cost share between NWC and James' trust (Eight votes)

Motion: That the *NSW Wildlife Council Annual Grants to Wildlife Carers Program* proposal developed and put forward by James Fitzgerald be adopted with the following two amendments:

- 1. The project is approved on a two year trial.
- 2. The project will be funded by the investment of \$2,500 p.a. from James' Trust, and \$2,500 p.a. by the NWC (subject to agreement by RMS).

A draft **anti** -bullying policy has been provided to the Council which will be circulated on the List for comment with the intent of including the policy in the NWC Code of Conduct.

#### **PRESENTATION: FAWNA Wildlife Reporting System**

Meredith Ryan FAWNA's President demonstrated FAWNA's online response to OEH's call for standardising annual reporting. The group has developed, in consultation with the WLMU, a wildlife records data input page accessed via FAWNA's webpage for FAWNA members.

The demonstration was of particular interest to a few members present as a possible template for their own groups.

Brendon Neilly and Allan McLean (WLMU) were in attendance for the demonstration and discussion.

#### Additional matter: Dissemination of Rehabilitation Policy and Codes of Practice.

Brendon Neilly suggested he could provide extra copies of various codes of practice and policies for distribution among member groups. It was agreed they would be supplied on a CD ROM, which will include *Rehabilitation of Protected Fauna Policy*, the *Code of Practice for Injured*, *Sick and Orphaned Protected Fauna*, the Code of Practice for Injured, Sick and Orphaned Koalas and the *Code of Practice for Injured*, *Sick and Orphaned Flying-foxes*, plus a small print run of the Rehabilitation Policy.

## 5. CHAIR'S REPORT

Lorraine referred to the Council's motto *Together we'll make a difference* in the context of the heat and emotion around the firearms licensing issue.

She reported on the following:

- The Executive's response to Brian Chetwynd's complaint regarding the election of officebearers and record in the draft AGM minutes;
- Slow progress in writing up the draft Strategic Plan;
- Letters written to Blue Mountains City Council supporting their lobbying to amend the *Companion Animals Act;* Jill Taylor congratulating her on her AOM; Lismore City Council supporting its draft Comprehensive Koala Plan of Management.
- Sounding-out of Jill Taylor and Andrew Ryan to be 'responsible persons' on the management committee of the Council's proposed Public Fund;
- The Executive's response to the removal of wildlife rehabilitators from the Animal Welfare Genuine Reason category of firearms licensing;
- Agenda arrangements for the constructive and timely meeting between Executive members and Sally Barnes, A/Chief Executive, OEH and Bob Conroy A/Chief Executive, Parks & Wildlife Group held on 27 February.

The report on meeting outcomes was presented at this point by vice-Chair Caroline Enfield (see agenda item 9.3).

Motion: That the Strategic Plan be streamlined into a short list of achievable goals and consequent actions for 2011-12, 2012-13, 2013-2014. **Moved:** Meredith Ryan **Seconded:** Audrey Koosmen **Motion carried.** 

Action: Chair to continue and adapt the work in progress for circulation to members.

Motion: That the NWC endorses the following membership of the management committee of the proposed Public Fund: James Fitzgerald, Shirley Lack, Jill Taylor, Andrew Ryan and Patrick Medway.

Moved: Audrey Koosmen Seconded: Julia McConnell Motion Carried.

The Secretary will send letters of invitation (enclosing a copy of the REO's Public Fund Management Committee nomination form) to Jill Taylor, Andrew Ryan and Patrick Medway.

Shirley Lack and James Fitzgerald will each fill out the Public Fund Management Committee Nomination Form at the May meeting.

Phil will forward the draft amendments of the Constitution to the Register of Environmental Organisations for preliminary advice of the relevant clauses prior to lodgement of application.

Meredith will draw up Draft Rules for the Public Fund for presentation at the May meeting and will take responsibility for preparing the NWC's application to be entered on the Register of Environmental Organisations

On approval of the Rules, the Treasurer will proceed with setting up the Fund's bank account

## 9. INSURANCE REPORT – Shirley Lack

The Insurance Officer advised that a claim was being processed. She also raised concern regarding the Firearms Licensing issue and the operational impacts on carers from all groups. (Detailed response to be included)

MOTION: That the NWC writes to WIRES regarding procedures and protocol associated with insurance matters, requesting an explanation of the actions surrounding the contact made with the Insurer and an apology for any breach of protocols.

## **10. GENERAL BUSINESS**

#### 10.1 Firearms

Some members expressed concern that applications for firearms licences for the purpose of humane euthanasia from wildlife carers were being refused with the withdrawal of volunteer wildlife rehabilitators from category 4 of the Animal Welfare Genuine Reason. Discussion ensued outlining the sequence of events that led to the Firearms Registry making this change. A couple of member groups were expressly concerned about their members being refused licences.

Also discussed were the Council's correspondence to the Firearms Registry requesting prompt clarification and the Registry's response, acknowledging understanding for the need for volunteers to euthanase injured native fauna, asserting need for specialist training and offering the option of wildlife rehabilitators applying for a Commissioner's Permit under Section 28(g) of the *Firearms Act*, which enables "...the possession and use of firearms in such circumstances as the Commissioner considers appropriate".

The Chair reiterated the exchange between herself and the Registry General Manager regarding his offer to forward an amendment to the Act to Parliamentary Counsel to include wildlife rehabilitators in Animal Welfare Genuine Reason.

The WIRES representative referred to her email posting to the Executive and Greg Tarlinton of 7 February explaining the facts as she knew them. In view of no further clarification being received from the WIRES **Board** she suggested that the letter to WIRES resolved earlier, include a request for clarification regarding discussions by the WIRES General Manager and Firearms Registry personnel.

Motion: The Council nominates James Fitzgerald and Greg Tarlinton to pursue negotiations to

resolve the Firearms Licensing issue by consulting with interested parties (OEH and the Firearms Registry) in developing an NWC accredited training course based on the course used by Wildcare Queanbeyan. **Moved:** Audrey Koosmen **Seconded:** Shona Lorigan **Motion carried.** 

Action: Members who have had a licence application refused should advise James of details.

#### Coralie and Greg Tarlinton left the meeting. (3:15pm)

#### 10.2 Marine Pollution Bill

Rochelle outlined the amendment passed through NSW Legislative Council regarding marine pollution, and the establishment of an oiled wildlife care network.
