INTRODUCTIONS:

Peter Stathis – General Introduction & Briefing

Peter Stathis gave a very informative briefing including OEH/NPWS restructuring issues, administration of compliance and training and the desire to improve communication and interaction between OEH/NPWS and the various carer groups.

Linda Crawley – NPWS Reptile Ballot System

Linda Crawley provided an interesting insight into whom and how native wildlife fauna can be held in captivity and what the process is for the assessment and ongoing management of animals seized from those not authorised to hold them. Particular attention was given to reptiles, a group which have become more prominent in being recovered from illegal possession.

The reptile ballot system was explained in detail showing how it was applied with fairness and transparency.

An appropriate license is the only legitimate way a person or group can hold any protected species.

WRSC recommended the NWC be represented at this conference by Audrey Koosemen, Chair and Shirley Lack, Treasurer, assisted by a NWC subsidy. FOK mentioned there was precedence for this where the NWC had previously subsidised council members to attend the ARWC in Townsville. The Treasurer had prepared some estimated costs to attend the conference.

WRSC identified the need to be more specific when notifying the amount and procedure for reimbursement of NWC authorised reimbursement of accommodation expenses.

Discussion took place on the need for the NWC to facilitate the provision of accommodation for attendance at approved NWC meetings on a case-by-case basis. The maximum reimbursement should be limited to the amount charged for the NWC to secure such suitable accommodation.

WRSC drew attention to the fact that Wildlife Rescue inc. was allegedly accepting monetary donations intended for another organisation due to confusion arising from the similarity of both group's name (ref. WRI Newsletter #7). The question being, does WRSC have any recourse to recovering such misplaced donations?

Discussion took place and council recommended this was a matter for both groups to address.

Further information provided indicates any outcome needs to be negotiated between both parties and there is no legal recourse.

6.7. NWC support to advance a database on microchips and tag numbers for released wildlife – Jane Mills

This was addressed by Linda Crawley earlier in the meeting (Item 1 -Address To The Council). NPWS encourages this approved practice which is currently being done by them. A discussion paper will be prepared for distribution to all member groups. It was recommended a data base recording such details be established.
